This edition of the Oakham General Bylaws includes amendments adopted at the Annual Town Meeting, June 27, 2022. Approved by Attorney General Maura Healey, January 4, 2023.

Chapter 40A Section 5 Effective date of bylaw amendment

The effective date of the adoption or amendment of any zoning ordinance or by-law shall be the date on which such adoption or amendment was voted upon by a city council or town meeting; if in towns, publication in a town bulletin or pamphlet and posting is subsequently made or publication in a newspaper pursuant to Chapter 40 Section 2.

A true copy of the zoning ordinance or by-law with any amendments thereto shall be kept on file available for inspection in the office of the clerk of such city or town.
